If our support results in a publication, the contribution of the Core Facility Statistical Consulting should be recognized in an appropriate way (e.g. acknowledgement or co-authorship). Manuscripts must be approved by the Core Facility in case the support is mentioned. This is not relevant if your request regards a statistical opinion for an animal experiment.

If we receive (personal) data from you for consultation and/or analysis, you are responsible for ensuring that necessary data protection rules are followed with regard to this data and that appropriate precautions (e.g. anonymization of data) are taken.

If, in the course of consultation and/or analysis, you intend to transfer personal data that you have collected as the person responsible to us, we would like to ask you to take appropriate precautions, such as making the data anonymous, in advance of the transfer.

The data should no longer contain any identifying characteristics such as name, date of birth or address when transferred. In the case that such anonymization is not possible, please contact CF-stats-consulting@helmholtz-munich.de in advance so that we can make the necessary data protection agreements with you.
